### **New News on Migrating Monarchs**

The United States Fish and Wildlife Service (USFWS) is proposing to designate the monarch butterfly as a threatened species, one step below endangered, as federal scientists believe the population is on the decline. If the proposed rule is finalized, it would afford protection to the butterfly from certain situations, including development and agriculture methods.

The USFWS believes the move to be necessary due to climate change, logging in overwintering habitat, grassland



decline, and chemicals applied to plants and insects. Protecting the monarch under the Endangered Species Act would probably require large landowners to work with the federal government before doing any development that could significantly harm the monarch's habitat.

Feedback on the proposal is being accepted until March 12 with plans to finalize the decision by the end

of 2025. It is unclear what the new administration will mean to the proposal as federal scientists found a drop in the populations years ago, but it was determined that other species should take priority. Stay tuned!



### **Conserving Copperheads!**

Students at Western Connecticut State University (WCSU) have been conducting research on copperhead snakes. These long-lived predators are heavily impacted by people in a variety of ways, including urbanization, road-building, and agriculture. Copperheads are found in central

Connecticut but are not commonly seen. The research sponsored by WCSU, in cooperation with DEEP and Quinn Ecological, LLC, is seeking to determine and prevent declines in the population. Andrew Powers, a graduate student at the university, is studying the effects of urbanization on copperheads in Connecticut. Other aspects of the study include determining how they respond to drought conditions, how many young they are having, their diet, and the affect of movement on the snakes. If snakes are captured, they are fitted with a tag to monitor their movements. Hopefully, the reseach will help us better understand these remarkable snakes.

# Winter Bird Feeding & Bears

It is often said that putting up a bird feeder is like placing a welcome mat out for black bears. This can be true in bear country! The enjoyment of watching birds is worth the risk for many homeowners. Certain steps can be taken to minimize the likelihood of a black bear visitor.



Although black bears can be active at any time of the day, removing feeders at night may help in some situations. Also, feeding birds only during the coldest days of winter and not allowing spilt seed to pile up underneath feeders is recommended. If a bear does access your feeder, remove it immediately and cease feeding for the season. Be sure to remove feeders altogether when the weather warms during late winter/early spring.

### What's that tiny bird flitting about the bushes?

If the bird is really small and has either a yellow or red patch on the head, it is likely one of the kinglets! Golden- or ruby-crowned kinglets are very active songbirds with rounded bodies, short wings, and skinny



tails. They are smaller than a chickadee. In winter, kinglets search for insects or spiders hidden in evergreen needles, on bark, or among twigs on trees and shrubs. They also eat a small amount of seeds and fruit. Breeding location for kinglets is up north in the conifers so enjoy the birds use of winter habitat while you can!
